## **Consultation documents Overview & Next Steps**

The draft proposal for amendments and corrections to the ITS on Reporting and ITS on Disclosure address the Commission Delegated Regulation (EU).../... (C(2019) 1900), amending Delegated Regulation (EU) 2015/35 and the Commission Delegated Regulation 2018/1221 of 1 June 2018 amending Delegated Regulation (EU) 2015/35 as regards the calculation of regulatory capital requirements for securitisations and simple, transparent and standardised securitisations held by insurance and reinsurance undertakings. Some of the proposals under consultation are based on the amendments to the Delegated Regulation (EU) 2015/35 that have been adopted by the COM on 8 March 2019 and are currently under the scrutiny period of the European Parliament and the Council.

In addition, the closed list of the nominated ECAIs has been also amended to reflect the changes done through the last year in the ESMA list e.g. new registration and withdrawn of existing registrations.

There is only one correction included in the draft amendments and corrections, which addresses an error in the instructions of the template "S.25.02 - Solvency Capital Requirement" – for groups using the standard formula and partial internal model.

The amendments proposed were kept to the minimum and they do not reflect a detailed review of the requirements, which will be part of the Reporting and Disclosure Review 2020. The amendments aim to align the reporting and disclosure with the amendments to the Delegated Regulation (EU) 2015/35.

### **Which are the documents for consultation?**

This call for comments includes the following documents:

1. Draft amendment to Commission Implementing Regulation (EU) 2015/2450 of 2 December 2015 laying down implementing technical standards with regard to the templates for the submission of information to the supervisory authorities;
2. Draft amendment to Commission Implementing Regulation (EU) 2015/2452 of 2 December 2015 laying down implementing technical standards with regard to the procedures, formats and templates of the solvency and financial condition report;
3. Impact Assessment;
4. Template for Comments.

### **Next steps**

EIOPA will consider the responses it receives to this consultation, and will finalise the draft amendments and corrections to the ITS on Reporting and ITS on Disclosure.

The draft amendments and corrections to the ITS on Reporting and ITS on Disclosure will then be submitted to the European Commission for endorsement.

All corrections and amendments and the update of the taxonomy validations will be incorporated in the XBRL taxonomy version 2.4.0. which public working draft should be published by 3 June for consultation and final version published by 15 July, in line with the Governance of Taxonomy Releases.
