# 4. Mediation Panel - election

Decision by SMV<sup>1</sup>

## **Conclusions and Action points**:

- Adams, Julian (UK) and Kellermann, Joanne (NL) were elected as EIOPA's Mediation Panel members. Simoniti, Sergej (SI) was elected as EIOPA's Mediation Panel substitute.
- EIOPA to launch a second call for candidates in order for the 3 open substitutes' positions to be filled in. Election of substitutes will take place at the next Board of Supervisors meeting in November.

# 5. Stress Test and Long Term Guarantee Assessment

Decision by SMV<sup>1</sup>

# **Conclusions and Action points:**

- The BoS approved the "pre-stress" specifications on SCR etc. to be used for LTGA and agreed to publish these as soon as possible. The title of the document will be changed to clarify the use for LTGA.
- EIOPA to send the LTGA specifications to BoS for a written procedure after the completion of the ToR.
- The BoS approved a postponement of the Stress Test to early 2013 with full scope based on end 2012 data.

# 6. Solvency II

Decision by SMV<sup>1</sup>

#### **Conclusions and Action points:**

- The BoS supports the ongoing work to develop the technical standards and guidelines including the approach to be taken to conduct an impact assessment (individual and cumulative), to analyse the approach to proportionality, to analyse the level of convergence and to conduct further consistency checks.
- Given the importance of the issue of proportionality, the outcome of the work on proportionality will be used to develop a strong case to enable EIOPA to justify the approach taken. The analysis will form the basis of specific section within the consultation papers.
- IGSRR to develop guidelines requiring an external audit of the elements of the SFCR.
- In view of the potential costs, particularly for smaller undertakings, of using external audits, the BoS asked the IGSRR to consider how the guidelines might be applied proportionally in terms of (1) whether the guidelines should apply to all parts of the SFCR, and (2) whether the scope of the information to be subjected to external audit, as opposed to external or independent scrutiny, could be limited.
- A work stream chaired by EIOPA staff and IGSC and Equivalence Committee members is to be set up to consider the questions raised by FinMa with the intention of agreeing on principles to be used when coordinating with FinMa. These principles will form the basis of further developments on how to apply equivalence in practice.
- The list of selected data/indicators for the information to be exchanged between colleges should be included in a separate Guideline.

# 8. ITDC

Decision by SMV<sup>1</sup>

# Conclusions and Action points:

- The BoS approved the EIOPA Enterprise Architecture Change Management Process assuring the proper Board of Supervisors' involvement in proceeding of further developments.
- EIOPA should, under the umbrella of its crisis prevention and management responsibilities, be allowed to request for detailed, firm level reporting templates to be used on an exceptional basis. The task force on crisis management has provided the BoS earlier with descriptions of exceptional and emergency situations that has been approved by the BoS and forms the basis of the business processes' description.
- The BoS approved the scope of data to be transmitted to EIOPA. The scope was derived from the present EIOPA Business Processes descriptions defining EIOPA's tasks basing on EIOPA's Regulation and contains amongst others the individual group reports of cross-border groups and individual financial stability reports of undertakings above the threshold (for colleges, financial stability and crisis prevention work within EIOPA).
- The BoS adopted the EIOPA IT Architecture as a basis for the further development of the systems.
- The BoS mandated ITDC to further investigate the data classification systems used by the Members by sending out a questionnaire. The conclusions will be presented to the BoS during the November meeting.

## 9. Pensions – Final technical specifications for QIS

Decision by SMV<sup>1</sup>

# **Conclusions and Action points:**

- The BoS adopted the draft technical specifications for the QIS for submission to the COM and publication on EIOPA's website, subject to minor changes.
- A reference was included to further work and public consultation on an improved methodology for the calculation of sponsor support with a view to completing an assessment of this key factor, ideally in time to contribute to the current QIS.
- The BoS approved the reasoned feedback on consultation responses for publication on EIOPA's website.
- The BoS decided to validate the QIS results at EIOPA based on individual (anonimised) data.
- The BoS approved the note on process for coordination of QIS exercise and validation of results.
- It was agreed that the validation schematic should be agreed in advance with the

# Conclusions and Action points:

- The BoS agreed that EIOPA's overall strategy for the evaluation is to ensure that it is assessed as having in general positively fulfilled and complied with its mandate and obligations, taking into account the restrictions in resources and time and that it has done so whilst simultaneously establishing organisational and administrative procedures and frameworks.
- The BoS agreed to the list of EIOPA's main achievements until now.
- Members will be involved in the evaluation via the COM as one of the stakeholders providing input.
- EIOPA will draft the self-assessment report, to be shared with the BoS in the November meeting.
- The EIOPA strategy day "Reflecting visions for the future of EIOPA" on 25 October 2012 will provide additional input from Members for the self-assessment report and the work on proposed amendments to the EIOPA Regulation, to be started early 2013.

#### **Conclusions and Action points:**

- The BoS adopted the Report on a mapping exercise on Industry Training Standards applied by national competent authorities.
- The BoS adopted the One-Minute Guide on the Guidelines on complaints-handling by insurance undertakings.
- The One-Minute Guide will be published on EIOPA's website at the same time as the translations of the Guidelines on complaints-handling by insurance undertakings, are published.
