	 report is an important step. The positive EIOPA recommendations reflect our experience of the closeness of the Swiss and EU supervisory approaches and the advanced regulatory practices applied by FINMA. The positive findings reflect the constant efforts within Switzerland to establish and maintain a fruitful cooperation between the Swiss and EU supervisory regimes. We trust that the in-depth dialogue between EIOPA and FINMA in this equivalence process will continue. We are aware that FINMA is currently reviewing the issue of public disclosures and support that this point should be revisited once the internal review in Switzerland is concluded and common practices have been established taking also international accounting standards as well as public listing rules into account. There is already an emerging market practice towards the disclosure of certain key SST numbers, which we consider to be in line with the spirit of the Solvency II framework. Finally, from an industry perspective, we are not aware of dispensations being granted for the audit or compliance functions at the group level, so this possibility should be idle regulation in practice. We would recommend focusing on the supervisory practice in this regard when assessing the equivalence of the Swiss insurance supervisory regime. We are confident that the dialogue with FINMA and continued public transparency of the process, will allow for full equivalence. This will be an important step to achieve the ultimate goal to strengthen 	
<u> </u>	supervisory cooperation at the international level.
